CITY CHAMPIONSHIP INFORMATION Life Time Athletic Peachtree Corners

Captains <u>only</u> must check in at the tournament table at least ½ hour prior to your scheduled match time. Your entire team must be present on the grounds before you check in. The captain will complete the championship scorecard. Once completed, no change can be made except for injury to a player during warm-up. *Please be sure your ENTIRE team is present at least ½ hour before your scheduled match time.* It is especially important for those in the first time slot to be there on time. The first matches will start as soon as both teams are present!

All matches will be scheduled for play at the same time, providing courts are available, and must be played to completion unless otherwise directed by the Program Director.

The format for city finals is best 2 out of 3 sets with a mandatory 10 pt tiebreak in lieu of a complete 3rd set.

Balls will be provided by USTA. Players should make certain that they are on the specific court to which they are assigned and that they are playing the proper opponents.

Each team is responsible for their drinks and refreshments. There is a café on site at Life Time that should be used for purchasing food. Desserts and light refreshments may be at your table but Life Time does not allow outside food to be brought in that can be purchased from their café. Bathroom visits, filling of water jugs and stretching is to be done in advance so that the players can take the courts immediately upon being called to start warm-ups. Delays may result in point penalties.

Warm-up is limited to ten (10) minutes, including serves. When the warm-up is complete an USTA Atlanta representative will instruct players to begin and play must start immediately. One member of each doubles team and each singles player must come to the desk to report the score as soon as the match is completed.

Every effort will be made to complete all matches on the scheduled days of the City Championship. However, if there is rain at Life Time on the scheduled day and no matches are played, the entire schedule will move to the rain date. If only part of the tournament is cancelled due to weather, the make up schedule will be decided upon by the Program Director.

It is our goal to adhere to the schedule. However, captains must be aware that flexibility is the key to any successful tournament. Please make sure that your team is available for the entire day
